The Class B ordinary shares beneficially owned by ATAC Sponsor LLC (the "Sponsor") include up to 750,000 shares subject to forfeiture depending on the extent to which the underwriters' over-allotment option to purchase additional units is exercised in connection with the Issuer's initial public offering, as described in the Registration Statement.

2. The securities are held directly by the Sponsor and indirectly by Zachary Wang, Cathryn Chen and Yida Gao as managers of ATAC Manager LLC, managing member of the Sponsor.
